NOT ONCE IN MY LIFE DID I EVER PLAN ON RUNNING FOR PUBLIC OFFICE UNTIL 2013. I AM VERY PATRIOTIC AND THAT LED ME TO SERVE 7 YEARS IN THE ARMED FORCES. I FELT OBLIGATED TO SERVE. SO MANY HAVE GIVEN THEIR LIVES FOR MY FREEDOM. I FELT A PERSONAL RESPONSIBILITY TO SERVE AND PAY FORWARD FOR MY CHILDREN TO HAVE A FREE LIFE.

I HAVE ALWAYS BEEN ACTIVE IN POLITICS IN SOME WAY. I HAVE ATTENDED RALLYS. STOOD UP FOR WHAT I THOUGHT WAS RIGHT. I HAVE PARTICIPATED IN SIGNATURE GATHERING FOR INITIATIVES I BELIEVED IN.

ON MORE THAN ONE OCCASION I GATHERED SIGNATURES FOR INITIATIVES THAT LIMITED LEGISLATORS ABILITY TO CREATE NEW TAXES. INITIATIVE 960 WAS ONE OF THOSE INITIATIVES.

THE ELECTORATE PASSED THAT INITIATIVE WITH NEARLY 70 PERCENT APROVAL ACROSS THE STATE.

THE DEMOCRATIC CONTROLLED HOUSE AND SENATE SUSPENDED THE INITIATIVE AND PROCEEDED TO RAISE TAXES 6.7 BILLION DOLLARS OVER A TEN YEAR PERIOD. THE HOUSE MAJORITY LEADER AT THE TIME WAS PAT SULLIVAN, MY STATE REPRESENTATIVE.

THIS IS NOT THE ONLY TIME PAT SULLIVAN SLAPPED THE VOTERS IN THE FACE. HE ALSO ORIGINATED A BILL THAT EFFEXTIVELY KILLED THE "SMALLER CLASS SIZE NOW" INITIATIVE. HIS BILL SUSPENDED FUNDING THE INITIATIVE FOR FOUR YEARS.

I SUDDENLY FELT A NEW CALL TO DUTY. I FELT OBLIGATED TO STEP FORWARD AND BRING A CONSERVATIVE VOTE FOR MY DISTRICT TO THE LEGISLATIVE FLOOR. THE CITIZENS WERE NOT GETTING WHAT THEY DEMANDED FROM THEIR LEADER.

OUR ELECTED OFFICIAL WAS NOT LEGISLATING ON OUR BEHALF, INSTEAD HE LEGISLATES FOR ANOTHER CAUSE. WEATHER IT IS PARTY OR LOBBY OR SPECIAL INTEREST GROUP MAKES NO DIFFERENCE TO ME. HE IS OUT OF TOUCH WITH THE ELECTORATE.

I FEEL STRONGLY THAT MORE LOCAL BUSINESS PEOPLE SHOULD STEP FORWARD AND REPLACE THE CAREER POLITICIANS SUCH AS SULLIVAN.

I POSESS A VERY STRONG SENSE OF MORALITY AND ETHICS THAT SULLIVAN DOES NOT DEMONSTRATE.

I WILL MAKE A CLEAR DECISION WITHOUT ANY HESITATION, EVEN TO THE DETRIMENT OF MYSELF, IF IT'S THE RIGHT THING TO DO.

I SEE ELECTED OFFICIALS MAKING DECISIONS ALL THE TIME THEY CLEARLY KNOW ARE NOT THE RIGHT THING TO BUT THEY DO IT ANYWAY FOR VOTES OR FAVORATISM OR FOR THEIR RESUME.

MOST RECENTLY IN THE SENATE THERE WAS A BILL PROPOSED THAT WOULD HAVE REVERSED THE HUMAN RIGHTS COMMISSION RULING OF TRANS GENDER BATHROOM ISSUES. THREE REPUBLICANS JOINED FORCES WITH DEMOCRATS TO KILL THE BILL. THEY ALL KNOW THIS WILL MIX LOCKER ROOMS IN SCHOOLS. THEY ALL KNOW THIS WILL LEAD TO PROBLEMS AND MOST LIKELY LAW SUITS. YET THEY VOTED IN FAVOR OF KILLING THE BILL FOR REASONS ONLY THEY TRULY KNOW.

I WAS INCHARGE OF ENGINE ROOMS, I ACTED AS A DRUG INTERDICTION BOARDING TEAM MEMBER. AS A REWARD FOR MY EFFORTS I WAS GIVEN DUTY AS A LIGHT HOUSE KEEPER. I AM AN AMERICAN LEGION MEMBER TODAY.

AFTER LEAVING THE SERVICE I STARTED MY OWN CONSTRUCTION COMPANY. I WENT TO OTHER SPECIALTY CONTRACTORS JOB SIGHTS AND OFFERED TO WORK FOR FREE IF THAY TAUGHT ME THEIR TRADE. WITHIN 4 YEARS I WAS RUNNING HEAVY EQUIPMENT, CLEARING LAND, FORMING AND POURING FOUNDATIONS AND FRAMING HOUSES. I RAN A SUCCESSFULL CONSTRUCTION COMPANY FOR 17 YEARS UNTIL THE ECONOMIC COLLAPSE OF 2007 CLOSED ME DOWN.

I HAVE A VARY CREATIVE MIND. I HAVE DEVELOPED THREE PRODUCTS. I HAVE HELD PROVISSIONAL PATENTS ON TWO OF THEM. I MARKET AND SELL TWO OF THESE PRODUCTS TODAY.
